



Terms and conditions Gården's Boutique Rotterdam

1. Everyone must adhere to our corona regulations (see page 2);
2. Only artists from Rotterdam-Rijnmond;
3. All genres, including instrumental and electronic;
4. Own work only. The artist must be the owner of the tracks to be recorded;
5. Artists can sing along about their own backing track (such as [Colors](#)) or accompany themselves on an (electronic) instrument;
6. Provide a set between a minimum of 8 minutes and a maximum of 15 minutes (electronic sets between a minimum of 15 minutes and a maximum of 30 minutes);
7. Sessions last an hour and a half: 30 minutes of build-up, 30 minutes of recording time, 30 minutes of breakdown. Artists must be present fifteen minutes before building up;
8. Sessions are recorded with at least three cameras, edited afterwards and broadcast at a later date. Afterwards Gården makes a separate montage of one track. The artist will receive a copy of this video and may use it for promotional purposes such as for a press kit, teasers social media channels, etc, but not for commercial purposes such as posting on YouTube, etc .;
9. Each musician receives an expense allowance of 50 euros (if an act consists of two musicians, the total expense allowance is 100 euros);
10. The artist gives Gården the right to publish, without compensation and unlimited (parts of) the video recordings on the website of Gården and its video and social media channels. Athis purpose in advance *copyright statement is signed for*;
11. The recordings are the property of Gården and are not sold to third parties;
12. The videos refer to the artist's online channels;
13. The partners of Gården in this project (Studio SanteBoutique, dante.media and Arty Farty) may use images of maximum 1 minute to promote (their contribution to) the project;
14. 80% of any future income from the artist's video recordings published on the Gården channels will go to the artist. Garden withholds 20% for production and administration costs. Gården reports annually on this to the artist. In addition, the artist has the right to request an overview from Gården every quarter.

Corona regulations

1. Maximum two musicians per session;
2. The session is canceled if a musician or someone from Gården falls ill. If there is no space within the production schedule to record the session at another time, the session will unfortunately be canceled;
3. With each entry wash (even after smoking outside) hands;
4. Keep a minimum distance of 1.5 meters;
5. Coughing and sneezing in the elbow;
6. In the hallway between the studios, pass each other only by the kitchen;
7. Guests are not allowed to enter the studios and studio building. Do not bring guests and if this is impossible, guests should wait outside the studio building;
8. Artists must strictly adhere to the production times and leave the studio building immediately after the session;
9. We work with two studios, one for the audio recordings and one for the video recordings. The audio studio may not be entered. The video studio is 8 x 8 meters. It can accommodate a maximum of 5 people;
10. The audio is recorded with a limited number of microphones due to limited freedom of movement in the studio;
11. We advise to bring your own vocal microphone. Don't you have it? We work with windshields on our vocal microphones that are thrown away after every session, so that hygiene is optimal;
12. Coffee, tea and water is available from disposable cardboard cups. We advise artists to bring their own drinks;
13. For your own convenience, you can wear face masks and / or gloves. We wear as many gloves as possible, but this is unfortunately not always possible due to the operation of the recording equipment.
